**LEGISLATIVE BILL 225**

Introduced by Guereca, 7.

Read first time January 14, 2025

Committee:

- 1 A BILL FOR AN ACT relating to motor vehicles; to amend section 60-168,
- 2 Reissue Revised Statutes of Nebraska; to change application
- 3 requirements for duplicate certificates of title; and to repeal the
- 4 original section.
- 5 Be it enacted by the people of the State of Nebraska,

1           **Section 1.** Section 60-168, Reissue Revised Statutes of Nebraska, is  
2 amended to read:

3           60-168 (1) In the event of a lost or mutilated certificate of title,  
4 the owner of the vehicle or the holder of a lien on the vehicle shall  
5 apply, upon a form prescribed by the department, to the department or to  
6 any county treasurer for a duplicate certificate of title and shall pay  
7 the fee prescribed by section 60-156. The application shall be signed ~~and~~  
8 ~~sworn to~~ by the person making the application or a person authorized to  
9 sign under section 60-151. Thereupon the county treasurer, with the  
10 approval of the department, or the department shall issue a duplicate  
11 certificate of title to the person entitled to receive the certificate of  
12 title. If the records of the title have been destroyed pursuant to  
13 section 60-152, the county treasurer shall issue a duplicate certificate  
14 of title to the person entitled to receive the same upon such showing as  
15 the county treasurer may deem sufficient. If the applicant cannot produce  
16 such proof of ownership, he or she may apply directly to the department  
17 and submit such evidence as he or she may have, and the department may,  
18 if it finds the evidence sufficient, authorize the county treasurer to  
19 issue a duplicate certificate of title. A duplicate certificate of title  
20 so issued shall show only those unreleased liens of record. The new  
21 purchaser shall be entitled to receive an original certificate of title  
22 upon presentation of the assigned duplicate copy of the certificate of  
23 title, properly assigned to the new purchaser, to the county treasurer  
24 prescribed in section 60-144.

25           (2) Any purchaser of a vehicle for which a certificate of title was  
26 lost or mutilated may at the time of purchase require the seller of the  
27 same to indemnify him or her and all subsequent purchasers of the vehicle  
28 against any loss which he, she, or they may suffer by reason of any claim  
29 presented upon the original certificate. In the event of the recovery of  
30 the original certificate of title by the owner, he or she shall forthwith  
31 surrender the same to the county treasurer or the department for

1 cancellation.

2           **Sec. 2.**   Original section 60-168, Reissue Revised Statutes of  
3 Nebraska, is repealed.
