- Section 1. There is hereby appropriated (1) \$2,000 from the Auditor
- 2 of Public Accounts Cash Fund for FY2025-26 and (2) \$5,000 from the
- 3 Auditor of Public Accounts Cash Fund for FY2026-27 to the Auditor of
- 4 Public Accounts, for Program 525, to aid in carrying out the provisions
- 5 of Legislative Bill 306, One Hundred Ninth Legislature, First Session,
- 6 2025.
- 7 Total expenditures for permanent and temporary salaries and per
- 8 diems from funds appropriated in this section shall not exceed \$1,900 for
- 9 FY2025-26 or \$4,700 for FY2026-27.
- 10 Sec. 2. There is hereby appropriated (1) \$569,833 from the General
- 11 <u>Fund for FY2025-26 and (2) \$410,981 from the General Fund for FY2026-27</u>
- 12 <u>to the State Department of Education, for Program 25, to aid in carrying</u>
- 13 out the provisions of Legislative Bill 306, One Hundred Ninth
- 14 Legislature, First Session, 2025.
- 15 <u>Total expenditures for permanent and temporary salaries and per</u>
- 16 diems from funds appropriated in this section shall not exceed \$304,566
- 17 for FY2025-26 or \$226,122 for FY2026-27.
- 18 Sec. 3. There is hereby appropriated (1) \$250,000 from the General
- 19 Fund for FY2025-26 and (2) \$250,000 from the General Fund for FY2026-27
- 20 to the State Department of Education, for Program 158, to aid in carrying
- 21 out the provisions of Legislative Bill 306, One Hundred Ninth
- 22 <u>Legislature, First Session, 2025.</u>
- 23 There is included in the appropriation to this program for FY2025-26
- 24 \$250,000 General Funds for state aid, which shall only be used for such
