- 6 Be it enacted by the people of the State of Nebraska,

Section 1. Section 68-901, Revised Statutes Cumulative Supplement,

- 2 2024, is amended to read:
- 3 68-901 Sections 68-901 to 68-9,111 and section 2 of this act shall
- 4 be known and may be cited as the Medical Assistance Act.
- 5 Sec. 2. (1) The Legislature finds that: (a) Doula services have
- 6 been proven to reduce the cost of birthing and improve outcomes for
- 7 mothers and infants; (b) one of the most effective services to improve
- 8 labor and delivery outcomes is the continuous presence of support
- 9 personnel such as a doula; and (c) support from a doula is associated
- 10 with lower cesarean rates, as well as fewer obstetric interventions,
- 11 fewer complications, less pain medication, shorter labor hours, and
- 12 <u>higher Apgar scores for infants.</u>
- 13 (2) No later than January 1, 2027, the department shall reimburse a
- 14 provider for doula services. Such reimbursement shall be paid by state
- 15 <u>funds at rates determined by the department. The department shall submit</u>
- 16 <u>a state plan amendment, if necessary, to provide for reimbursement of</u>
- 17 doula services.
- 18 (3)(a) The department shall establish a work group of stakeholders
- 19 and experts to develop an implementation plan, including appropriate
- 20 reimbursement rates and appropriate training, certification, or
- 21 experience requirements for doula services. The work group shall submit
- 22 the implementation plan to the department no later than October 1, 2026.
- 23 (b) The work group shall be comprised of the following: (i) Thirty
- 24 percent of the members shall represent the doula profession; (ii) thirty
- 25 percent of the members shall represent communities of color
- 26 disproportionately impacted by poor birth outcomes; (iii) ten percent of
- 27 <u>the members shall represent rural Nebraska; and (iv) ten percent of the</u>
- 28 members shall have utilized doula services.
- 29 <u>(c) Additional members of the group shall include, but not be</u>
- 30 limited to: (i) Medical providers; (ii) public health professionals;
- 31 (iii) representatives of tribal organizations; and (iv) community

- 1 advocates.
- 2 (4)(a) For purposes of this section, doula means a trained
- 3 professional who provides emotional, physical, and informational support
- 4 for individuals before, during, and after labor and birth. This includes,
- 5 <u>but is not limited to, attending prenatal visits, support during</u>
- 6 delivery, and providing resources during the postpartum period.
- 7 (b) A doula shall have appropriate training, certification, or
- 8 experience, as determined by the implementation plan developed by the
- 9 work group described in subdivision (3)(a) of this section.
- (c) A doula shall not perform clinical or medical tasks and shall
- 11 <u>not diagnose or treat in any modality.</u>
