 17 on a patient who is anesthetized or unconscious in a hospital or medical  
 18 clinic without prior written consent unless:  
 19 (a) An individual authorized to make health care decisions for the  
 20 patient has given written consent for the examination;  
 21 (b) The examination is necessary for emergency diagnostic or  
 22 emergency treatment purposes; or  
 23 (c) A court orders the performance of the examination for the  
 24 collection of evidence.  
 25 (4) If an intimate examination is performed on an unconscious or  
 26 anesthetized patient pursuant to subsection (3) of this section, the  
 27 patient shall be notified in writing prior to discharge of such patient  
 1 from the hospital or medical clinic.  
 2 (5) A health care provider who violates subsection (3) of this  
 3 section is subject to discipline under the Uniform Credentialing Act.
