10 inspector registered or licensed with the State of Nebraska contracted as
11 a result of project specification requirements. Authorized inspector does
12 not include an individual performing a self-performed inspection for the

13 individual's own permit or building; and
 14 (b) Inspection records means the pass or fail results, including the
 15 reasons for failure or deviation from project specifications, of any
 16 inspection required by the permitting entity as a condition of
 17 construction in association with the address of the permit requested or
 18 issued.
 19 (2)(a) Any state agency, county, city, or village that requires an
 20 inspection as part of a building permit may allow for virtual inspection
 21 by an authorized inspector if the following conditions are met:
 22 (i) The inspection is of an area of a single-family or two-family
 23 residential building that is less than three stories in height and under
 24 ten thousand square feet;
 25 (ii) The individual requesting or holding the building permit has
 26 provided a list of contractors who are licensed or registered in such
 27 state, county, city, or village and who are completing the work to be
 1 virtually inspected; and
 2 (iii) Except as provided in subdivision (b) of this subsection, the
 3 virtual inspection is conducted live with both the individual requesting
 4 or holding the building permit and the authorized inspector.
 5 (b) Inspections required for building permits of a nonstructural
 6 nature, as determined by the permitting entity, may be conducted using
 7 video or photo documentation for any reinspection.
 8 (3) Any state agency, county, city, or village that utilizes virtual
 9 inspections shall not be required to publicize the list of contractors
 10 provided in subdivision (2)(a) of this section.
 11 Sec. 3. Original section 71-6401, Revised Statutes Cumulative
 12 Supplement, 2024, is repealed.
