for maybe a half hour at a time, these are the people I'm concerned about. The people...not the people who are camping even overnight or for two or three days, those I'm in complete agreement should have a user fee. Now, I would not object to that but I think somewhere in this bill and if it isn't in here now, I want you to try to see to it that there can be, that kind of flexibility worked into this thing. As far as...and I'm going to say one other thing about the Game Commission worrying about funding. I wish the Game Commission were as serious about funding when we had a bill here for two years running to try to garnish the money for the Game Commission for tourism and for other recreational purposes and they weren't nearly as interested in helping me get my bill passed at that time. Now, they are going to try to get it from the people that come in here and want to eat a picnic lunch and I don't agree with it.

SPEAKER: Well, we have several people lined up to speak and we actually still are speaking on the...Senator Kelly, Senator Marsh was ahead of you. Senator Marsh. We are speaking on the committee amendments to LB 255.

SENATOR MARSH: I have two comments. One to Senator Nore, we do not need to encourage people to come, they are already coming in great numbers and for Senator Luedtke. Senator Luedtke.

SPEAKER: Senator Luedtke.

SENATOR MARSH: Senator Luedtke, for your clarification, the roadside rest areas under the interstate highway system are not under the Game and Parks Commission but are under the Highway Commission and there would be no charge, whatsoever, for the interstate rest stops. So that is completely taken out of the picture.

SPEAKER: Senator Luedtke, do you care to respond.

SENATOR LUEDTKE: Mr. President, may I answer that this way. I understand there are some that are not that clearly defined as strictly Roads Department control and there is nothing that would keep the state of Nebraska from turning these over to the Game Commission and then they can charge a fee. I want to make sure that under no circumstances, I don't care who administers it, that they are not going to charge those wayside rest areas on the interstate.

SPEAKER: Thank you. Senator Syas.

SENATOR SYAS: We have special use areas that is under the Commission.

SPEAKER: That's correct.

SENATOR SYAS: That's right. This gets a little tangled up between the wayside special use areas.

SPEAKER: Well, the definitions, too. Senator Kelly, do you have some imput.

SENATOR KELLY: Mr. President, members of the body, I believe the committee hearings will show that this question was explored in the hearing and that the Games and Parks Commission definitely want to exclude the wayside areas on the interstate and they intend to and I'm sure they have absolutely no objection to writing it into the statute.

SPEAKER: The chair..the chair recognizes Senator Mahoney.

SENATOR MAHONEY: Mr. President, I would like to speak for a minute on this and ask Senator Luedtke, again, to listen to me for just a minute. I know for two times we had a bill here
