SENATOR CHAMBERS: Right. And, my concern about that is that people might look at what the rule says and presume that it is not printed because it is a lengthy amendment, when in reality it is not the length, but the nature of the amendment that caused the member to not want it to be printed. And, that is what I would like to avoid, if possible.

SENATOR WILL: Do you think that we can establish that by intent during this debate or would you be more comfortable putting something in the text of the rule.

SENATOR CHAMBERS: Do you mean by "establish it", establish that any amendment of no more than ten pages would be printed.

SENATOR WILL: Right.

SENATOR CHAMBERS: I'm wondering, because the Clerk and I have talked about this and other things that could develop where maybe, well I won't try to recite what was stated. I wish there was somehow we had a little more time to go through the situations and maybe we should just do it by discussing it as we are doing here.

SENATOR WILL: We might be able to, I think we have established on the record now what the current practice of the Clerk's Office is, and I think that you and I agree that that practice ought to occur and perhaps if anyone else has any thoughts that it might not, or whatever, they can jump in the discussion, but I think if we get on the record that we want that ten page rule, the informal rule to continue...

SENATOR CHAMBERS: Let me go on and give an example.

SENATOR COORDSEN: One minute.

SENATOR CHAMBERS: And I have been involved in things similar to this and I'm sure other senators have, where a long list of amendments is offered. And maybe the intent is not to take up all of them. Maybe not any of them if certain contingencies
