conversation that some of these cases, what was it 60 percent, I think, figure floated to someone said that, that are reviewed and 40 percent are not. Is that was your concern, I think, when you spoke first, Senator Hillman, and you can use my time, then after that one question.

SPEAKER WITHEM: Senator Hillman.

SENATOR HILLMAN: Yeah, to begin with when they first started this I was referring to a study that was looking at the review process with children placed out of the home and was there any duplication in the state of Nebraska. And we looked at the fact that there were three review systems put in place, and yet there were children that were not being reviewed. And so the purpose was to look at how to establish a, you know, a better review system and yet do away with some of the duplication. And there were several things that were suggested at that time. The other thing that comes into play is to be in compliance with the federal government, who will do that official review? Now, I think I'm correct in saying that with this legislation, that the compliance part of it would be with the courts. And I would go ahead and ask Senator Avery if that isn't the case. Senator Avery, please.

SPEAKER WITHEM: Senator Avery.

SENATOR AVERY: Yes.

SENATOR HILLMAN: And that currently the compliance part of it, as far as the reviews, is in the area of DSS, to be in federal compliance. And we're changing that, then, with this bill to the courts, is that correct?

SPEAKER WITHEM: Senator Avery.

SENATOR AVERY: Well, the court, there's reviews, the federal government says reviews can, don't have to fall totally with the courts. There's different entities that can do reviews. And we historically have had three different entities doing reviews. So you're right that that we are trying to eliminate one of those processes that isn't shared with anybody, and that was the department's reviews were kept in-house and weren't shared with all other parties. So I believe that the foster care review process is shared with all parties. Consequently, the courts
