corporations, many of them formed years and years ago and continuing to operate. They adopt a budget and they receive an allocated amount of levy, but they are nonprofit corporations. But, in many respects, they look like political subdivisions. They're subject to open meetings law, for example, they receive tax dollars, and you have to be a registered voter in a county to vote at an agricultural society's annual meeting. So, although oftentimes they are organized as nonprofit corporations, they have some characteristics of a political subdivision and, in fact, that causes some difficulties in our statutes that this is...that the bill cleans up. But what the bill does is create a third option for an entity to organize and carry on a county fair. Now, it doesn't require anyone to use this new option, but it makes it available, and the option that is available is a pure governmental subdivision and...but one that looks like a rural or suburban fire protection district in most of its characteristics. It doesn't have a board that's appointed by the county. The board would be elected on a...at the annual meeting, at least there's a...and there's a rotating system set up so that one-third of the board would be elected each year. The idea is that typically these organizations are kind of, if you will, a grass-roots organization. They can hold their annual meetings in that simple fashion and be able to elect directors and carry on their activities. The primary difference between that kind of organization and the agricultural society organization that is now in place is that it would very clearly be a political subdivision. Its property would be exempt from taxation; the board of directors in the organization would have the protection of the Tort Claims Act; it would be, of course, subject to the Budget Act; and it would, of course, be subject to the open meetings law. But it would be explicitly a governmental subdivision, not a hybrid organization, which may have some benefits for organizations in a given county. But, again, we're not requiring anyone to adopt that structure, simply making it possible to adopt that structure if it would work in your county to organize your county fair. Now, the...there is another important provision in the bill and it does concern the levies that are available to ag societies. As I've noted, they are not exactly a political subdivision and, when we passed 1114 and subsequent bills, we left out a little bit of language. We had language that said political subdivisions, the miscellaneous political
