that persons who choose to carry concealed weapons and draw a concealed weapon may have a great deal of difficulty in terms of knowing when legally it can be used and to what extent. And I tried to describe to you earlier the first part of the use of force in self-protection to give you a sense of how complicated the law is, and I wanted to continue a little bit where I left off, because I think there are some points that are worth discussing. But subsection (4) of subsection (1) after subsections (a), (b), and (c), say the use of deadly force shall not be justifiable under this section unless the actor, the one who has the weapon, believes that such force is necessary to protect himself, or I suppose herself, against death, serious bodily harm, kidnapping, or sexual intercourse compelled by force or threat. So, you see, there are certain kinds of actions against which you can protect yourself, but other kinds that you cannot protect yourself against with the use of deadly force. And I think one of the problems in some of these situations where an individual in society is called upon to make a snap judgment under stress is that, one, they're not going to remember what the law says in the first place and, secondly, regardless of what the law may say, their emotional state may be such that the offense threatened seems more serious to them than it would to an ordinary person looking in from the outside and, perhaps more importantly, it may seem less serious to a jury who's sitting some place very safe and secure and trying to decide months after whether the action the person took was reasonable or not reasonable in terms of their interpretation of the statute. You know, one of the reasons that we like to have the law enforced by law enforcement officers instead of by individual citizens is because, one, they know the law and, two, they're taught not to deal with things emotionally, but to strip emotion aside and look at things in terms of the cold hard facts. That's why we don't encourage vigilante groups, for example, or individuals generally take the law into their own hands, because of the emotion evolved...involved and because of the lack of knowledge of the intricacies of the law. And so, it should not surprise us that a person who chooses to draw a concealed weapon would be in a situation of some legal danger to themselves. And I don't think it was so long ago, and every once in a while you continue to hear the story about the convenience store clerk who shot an intruder, in a particular situation, and was, himself or herself, then subject to the
