SENATOR SCHROCK: Yes.

SENATOR CHAMBERS: And what this bill would do--and by "this bill," I mean the amendment we're looking at now--would be found on page 3, in lines 18-23, where there would be public notice required, and then the opportunity for a hearing, which would do away with the mandated hearing. Is that true?

SENATOR SCHROCK: That is correct.

SENATOR CHAMBERS: Where is this notice posted?

SENATOR SCHROCK: In the newspapers of concern, I suppose. It would have to be in the...where the facility is located.

SENATOR CHAMBERS: But it doesn't tell us where this notice would be posted, so a public notice could be a statement on a piece of paper nailed to the door of wherever this group meets, or it could be pasted on a telephone pole, or put in any place where the public could see it. Isn't that true?

SENATOR SCHROCK: It's current law, Senator Chambers, and it's contained in Title 115 of current laws, of the current law.

SENATOR CHAMBERS: And that that you're referring to states how public notice is to be given?

SENATOR SCHROCK: That is correct.

SENATOR CHAMBERS: You had mentioned that this group does not want to have to have these hearings, because few people show up for them.

SENATOR SCHROCK: Right.

SENATOR CHAMBERS: Senator Schrock, there are many...
