- LB 142 (*Williams*) Redefine effective financing statement and change provisions relating to the master lien list with respect to farm product security interests
- LB 182 (*Hughes*) Change powers and duties of the Department of Environmental Quality under the Drinking Water State Revolving Fund Act

- LB 6 *(Krist)* Provide for release of a summarized report by the office of Inspector General of Nebraska Child Welfare
- LB 207 *(Krist)* Change provisions relating to powers and duties of the Office of Inspector General of Nebraska Child Welfare
