- 1 A BILL FOR AN ACT relating to medical liens; to amend section 52-401,
- 2 Reissue Revised Statutes of Nebraska; to provide for a lien for
- 3 providers of emergency medical services; and to repeal the original
- 4 section.
- 5 Be it enacted by the people of the State of Nebraska,

Section 1. Section 52-401, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 52-401 (1) Whenever any person employs a physician, nurse,
- 4 chiropractor, or hospital, or provider of emergency medical service to
- 5 perform professional service or services of any nature, in the treatment
- 6 of or in connection with an injury, and such injured person claims
- 7 damages from the party causing the injury, such physician, nurse,
- 8 chiropractor, or hospital, or provider of emergency medical service as
- 9 the case may be, shall have a lien upon any sum awarded the injured
- 10 person in judgment or obtained by settlement or compromise on the amount
- 11 due for the usual and customary charges of such physician, nurse,
- 12 chiropractor, or hospital, or provider of emergency medical service
- 13 applicable at the <u>time</u> times services are performed, except that no such
- 14 lien shall be valid against anyone <u>covered</u> coming under the Nebraska
- 15 Workers' Compensation Act. For persons covered under private medical
- insurance or another private health benefit plan, the amount of the lien
- 17 shall be reduced by the contracted discount or other limitation which
- 18 would have been applied had the claim been submitted for reimbursement to
- 19 the medical insurer or administrator of such other health benefit plan.
- 20 The measure of damages for medical expenses in personal injury claims
- 21 shall be the private party rate, not the discounted amount.
- 22 (2) In order to prosecute such lien, it shall be necessary for such
- 23 physician, nurse, chiropractor, or hospital, or provider of emergency
- 24 <u>medical service</u> to serve a written notice upon the person or corporation
- 25 from whom damages are claimed that such physician, nurse, chiropractor,
- 26 or hospital, or provider of emergency medical service claims a lien for
- 27 such services and stating the amount due and the nature of such services,
- 28 except that whenever an action is pending in court for the recovery of
- 29 such damages, it shall be sufficient to file the notice of such lien in
- 30 the pending action.
- 31 <u>(3) A physician, nurse, chiropractor, or hospital, or provider of</u>

- 1 emergency medical service claiming a lien under this section shall not be
- 2 liable for attorney's fees and costs incurred by the injured person in
- 3 securing the judgment, settlement, or compromise, but the lien of the
- 4 injured person's attorney shall have precedence over the lien created by
- 5 this section.
- 6 <u>(4)</u> Upon a written request and with the injured person's consent, a
- 7 lienholder shall provide medical records, answers to interrogatories,
- 8 depositions, or any expert medical testimony related to the recovery of
- 9 damages within its custody and control at a reasonable charge to the
- 10 injured person.
- 11 (5) For purposes of this section, provider of emergency medical
- 12 <u>service means a public entity that provides emergency medical service as</u>
- defined in section 38-1207.
