Introduced by Bostar, 29; Ibach, 44. Read first time January 03, 2024 Committee: Health and Human Services

1 A BILL FOR AN ACT relating to child care licensing and child care 2 facilities; to amend sections 71-1911 and 71-1911.03, Reissue 3 Revised Statutes of Nebraska, and sections 28-713, 71-1908, 71-1912, 4 and 77-202, Revised Statutes Cumulative Supplement, 2022; to change requirements for child care licensing, liability insurance for child 5 6 care license applicants, background checks for child care employees, 7 and use of blankets in child care facilities; to provide reporting requirements to the Legislature for the Department of Health and 8 Human Services, the State Fire Marshal, and municipalities; to 9 provide a property tax exemption; to harmonize provisions; and to 10 repeal the original sections. 11

12 Be it enacted by the people of the State of Nebraska,

Section 1. Section 28-713, Revised Statutes Cumulative Supplement,
 2022, is amended to read:

3 28-713 (1) Unless a report is assigned to alternative response, upon the receipt of a call reporting child abuse and neglect as required by 4 5 section 28-711, it is the duty of the law enforcement agency to investigate the report, to take immediate steps to protect the child, and 6 7 to institute legal proceedings consistent with section 43-247 if the child is seriously endangered in the child's surroundings and immediate 8 9 removal is necessary for the protection of the child. The law enforcement 10 agency may request assistance from the department during the investigation and shall, by the next working day, notify either the 11 hotline established under section 28-711 or the department of receipt of 12 the report, including whether or not an investigation is being undertaken 13 14 by the law enforcement agency. A copy of all reports, whether or not an investigation is being undertaken, shall be provided to the department. 15

(2)(a) When a report is assigned for traditional response, the 16 17 department shall utilize an evidence-informed and validated tool to assess the safety of the child at the time of the assessment, the risk of 18 future child abuse or neglect, the need for services to protect and 19 assist the child and to preserve the family, and whether the case shall 20 be entered into the central registry pursuant to section 28-720. As part 21 22 of such investigation, the department may request assistance from the 23 appropriate law enforcement agency or refer the matter to the county attorney to initiate legal proceedings. 24

(b) If in the course of an investigation the department finds a child is seriously endangered in the child's surroundings and immediate removal is necessary for the protection of the child, the department shall make an immediate request for the county attorney to institute legal proceedings consistent with section 43-247.

30 (3) When a report contains an allegation of out-of-home child abuse31 or neglect, a law enforcement agency or the department shall immediately

1 notify each person having custody of each child who has allegedly been abused or neglected that such report has been made unless the person to 2 be notified is the subject of such report. The department or the law 3 4 enforcement agency shall provide such person with information about the nature of the alleged child abuse or neglect and any other necessary 5 information. The department shall also provide such social services as 6 7 are necessary and appropriate under the circumstances to protect and 8 assist the child and to preserve the family.

9 (4)(a) In situations of alleged out-of-home child abuse or neglect, 10 if the subject of the report of child abuse or neglect is a school 11 employee and the child is a student in the school to which such school 12 employee is assigned for work, the department shall immediately notify 13 the Commissioner of Education of receipt of the report, including whether 14 or not an investigation is being undertaken by the law enforcement agency 15 or the department.

16 (b) In situations of alleged out-of-home child abuse or neglect, if the subject of the report of child abuse or neglect is a child care 17 provider or a child care staff member as defined by subdivision (5)(i) 18 (5)(h) of section 71-1912, the Division of Children and Family Services 19 of the Department of Health and Human Services shall immediately notify 20 the Division of Public Health of the Department of Health and Human 21 22 Services of receipt of the report, including whether or not an 23 investigation is being undertaken by the law enforcement agency or the 24 department.

(5) The department shall, by the next working day after receiving a report of child abuse or neglect under this section, make a written report or a summary on forms provided by the department to the proper law enforcement agency in the county and enter in the tracking system of child protection cases maintained pursuant to section 28-715 all reports of child abuse or neglect opened for investigation and any action taken.

(6) The department shall, upon request, make available to the

appropriate investigating law enforcement agency and the county attorney
 a copy of all reports relative to a case of suspected child abuse or
 neglect.

4 (7)(a) In addition to the responsibilities under subsections (1) 5 through (6) of this section, upon the receipt of any report that a child 6 is a reported or suspected victim of sex trafficking of a minor or labor 7 trafficking of a minor as defined in section 28-830 and without regard to 8 the subject of the report, the department shall:

9 (i) Assign the case to staff for an in-person investigation. The 10 department shall assign a report for investigation regardless of whether 11 or not the subject of the report is a member of the child's household or 12 family or whether the subject is known or unknown, including cases of 13 out-of-home child abuse and neglect;

(ii) Conduct an in-person investigation and appropriately coordinate
with law enforcement agencies, the local child advocacy center, and the
child abuse and neglect investigation team under section 28-729;

17 (iii) Use specialized screening and assessment instruments to identify whether the child is a victim of sex trafficking of a minor or 18 19 labor trafficking of a minor or at high risk of becoming such a victim and determine the needs of the child and family to prevent or respond to 20 abuse, neglect, and exploitation. On or before December 1, 2019, the 21 department shall develop and adopt these instruments in consultation with 22 23 knowledgeable organizations and individuals, including representatives of 24 child advocacy centers, behavioral health providers, child welfare and juvenile justice service providers, law enforcement representatives, and 25 prosecutors; and 26

(iv) Provide for or refer and connect the child and family to services deemed appropriate by the department in the least restrictive environment, or provide for safe and appropriate placement, medical services, mental health care, or other needs as determined by the department based upon the department's assessment of the safety, risk,

and needs of the child and family to respond to or prevent abuse,
 neglect, and exploitation.

3 (b) On or before July 1, 2020, the department shall adopt rules and 4 regulations on the process of investigation, screening, and assessment of 5 reports of child abuse or neglect and the criteria for opening an ongoing 6 case upon allegations of sex trafficking of a minor or labor trafficking 7 of a minor.

(8) When a preponderance of the evidence indicates that a child is a 8 9 victim of abuse or neglect as a result of being a trafficking victim as 10 defined in section 28-830, the department shall identify the child as a victim of trafficking, regardless of whether the subject of the report is 11 a member of the child's household or family or whether the subject is 12 13 known or unknown. The child shall be included in the department's data and reporting on the numbers of child victims of abuse, neglect, and 14 trafficking. 15

 2022, is amended to read:

18 71-1908 (1) Sections 71-1908 to 71-1923 <u>and sections 6 to 10 of this</u>
 19 <u>act shall be known and may be cited as the Child Care Licensing Act.</u>

(2) The Legislature finds that there is a present and growing need 20 for quality child care programs and facilities. There is a need to 21 establish and maintain licensure of persons providing such programs to 22 ensure that such persons are competent and are using safe and adequate 23 Legislature further finds and declares that the 24 facilities. The 25 development and supervision of programs are a matter of statewide concern and should be dealt with uniformly on the state and local levels. There 26 27 is a need for cooperation among the various state and local agencies which impose standards on licensees, and there should be one agency which 28 coordinates the enforcement of such standards and informs the Legislature 29 about cooperation among the various agencies. 30

71-1911 (1) A person may operate child care for three or fewer 2 children without having a license issued by the department. A person who 3 4 is not required to be licensed may choose to apply for a license and, upon obtaining a license, shall be subject to the Child Care Licensing 5 Act. A person who has had a license issued pursuant to this section and 6 has had such license suspended or revoked other than for nonpayment of 7 fees shall not operate or offer to operate a program for or provide care 8 9 to any number of children until the person is licensed pursuant to this 10 section.

(2) No person shall operate or offer to operate a program for four 11 or more children under his or her direct supervision, care, and control 12 at any one time from families other than that of such person without 13 having in full force and effect a written license issued by the 14 department upon such terms as may be prescribed by the rules and 15 16 regulations adopted and promulgated by the department. The license may be 17 a provisional license or an operating license. A city, village, or county which has rules, regulations, or ordinances in effect on July 10, 1984, 18 which apply to programs operating for two or three children from 19 different families may continue to license persons providing such 20 programs. If the license of a person is suspended or revoked other than 21 for nonpayment of fees, such person shall not be licensed by any city, 22 23 village, or county rules, regulations, or ordinances until the person is 24 licensed pursuant to this section.

(3) A provisional license shall be issued to all applicants following the completion of preservice orientation training approved or delivered by the department for the first year of operation. At the end of one year of operation, the department shall either issue an operating license, extend the provisional license, or deny the operating license. The provisional license may be extended once for a period of no more than six months. The decision regarding extension of the provisional license

1 is not appealable. The provisional license may be extended if:

2 (a) A licensee is unable to comply with all licensure requirements
3 and standards, is making a good faith effort to comply, and is capable of
4 compliance within the next six months;

5 (b) The effect of the current inability to comply with a rule or 6 regulation does not present an unreasonable risk to the health, safety, 7 or well-being of children or staff; and

8 (c) The licensee has a written plan of correction that has been 9 approved by the department which is to be completed within the renewal 10 period.

(4) The department may place a provisional or operating license on 11 corrective action status. Corrective action status is voluntary and may 12 be in effect for up to six months. The decision regarding placement on 13 corrective action status is not a disciplinary action and is not 14 appealable. If the written plan of correction is not approved by the 15 department, the department may discipline the license. A probationary 16 17 license may be issued for the licensee to operate under corrective action status if the department determines that: 18

(a) The licensee is unable to comply with all licensure requirementsand standards or has had a history of noncompliance;

(b) The effect of noncompliance with any rule or regulation does not present an unreasonable risk to the health, safety, or well-being of children or staff; and

(c) The licensee has a written plan of correction that has beenapproved by the department.

26 (5) No child care licensee shall be prohibited from obtaining a dual
 27 license for the purpose of complying with attendance requirements.

(6) (5) Operating licenses issued under the Child Care Licensing Act
 shall remain in full force and effect subject to annual inspections and
 fees. The department may amend a license upon change of ownership or
 location. Amending a license requires a site inspection by the department

1 at the time of amendment. When a program is to be permanently closed, the 2 licensee shall return the license to the department within one week after 3 the closing.

4 <u>(7)</u> (6) The license, including any applicable status or amendment, 5 shall be displayed by the licensee in a prominent place so that it is 6 clearly visible to parents and others. License record information and 7 inspection reports shall be made available by the licensee for public 8 inspection upon request.

10 amended to read:

71-1911.03 An applicant for a license under the Child Care Licensing 11 Act shall provide to the department written proof of liability insurance 12 13 coverage for the hours such applicant is operating and a child is in the applicant's care of at least one hundred thousand dollars per occurrence 14 prior to issuance of the license. A licensee subject to the Child Care 15 Licensing Act on July 1, 2014, shall obtain such liability insurance 16 17 coverage and provide written proof to the department within thirty days after July 1, 2014. Failure by a licensee to maintain the required level 18 19 of liability insurance coverage shall be deemed noncompliance with the Child Care Licensing Act. If the licensee is the State of Nebraska or a 20 political subdivision, the licensee may utilize a risk retention group or 21 22 a risk management pool for purposes of providing such liability insurance coverage or may self-insure all or part of such coverage. 23

26 71-1912 (1) Before issuance of a license, the department shall 27 investigate or cause an investigation to be made, when it deems 28 necessary, to determine if the applicant or person in charge of the 29 program meets or is capable of meeting the physical well-being, safety, 30 and protection standards and the other rules and regulations of the 31 department adopted and promulgated under the Child Care Licensing Act.

1 The department may investigate the character of applicants and licensees, 2 any member of the applicant's or licensee's household, and the staff and 3 employees of programs. The department may at any time inspect or cause an 4 inspection to be made of any place where a program is operating to 5 determine if such program is being properly conducted.

6 (2) All inspections by the department shall be unannounced except 7 for initial licensure visits and consultation visits. Initial licensure 8 visits are announced visits necessary for a provisional license to be 9 issued to a family child care home I, family child care home II, child 10 care center, or school-age-only or preschool program. Consultation visits 11 are announced visits made at the request of a licensee for the purpose of 12 consulting with a department specialist on ways of improving the program.

(3) An unannounced inspection of any place where a program is operating shall be conducted by the department or the city, village, or county pursuant to subsection (2) of section 71-1914 at least annually for a program licensed to provide child care for fewer than thirty children and at least twice every year for a program licensed to provide child care for thirty or more children.

(4) Whenever an inspection is made, the findings shall be recorded in a report designated by the department. The public shall have access to the results of these inspections upon a written or oral request to the department. The request must include the name and address of the program. Additional unannounced inspections shall be performed as often as is necessary for the efficient and effective enforcement of the Child Care Licensing Act.

(5)(a) A person applying for a license as a child care provider or a licensed child care provider under the Child Care Licensing Act shall submit a request for a national criminal history record information check for each child care staff member, including a prospective child care staff member of the child care provider, at the applicant's or licensee's expense, as set forth in this section.

1 (b) A Beginning on October 1, 2019, a prospective child care staff 2 member shall submit to a national criminal history record information check (i) prior to employment, except as otherwise permitted under 45 3 4 C.F.R. 98.43, as such regulation existed on January 1, 2019, or (ii) 5 prior to residing in a family child care home. A child care staff member 6 who was employed by a child care provider prior to October 1, 2019, or 7 who resided in a family child care home prior to October 1, 2019, shall submit to a national criminal history record information check by October 8 9 1, 2021, unless the child care staff member ceases to be a child care 10 staff member prior to such date.

11 (c) The department shall provide documentation of national criminal 12 history record information checks which proves eligibility for 13 employment. Such documentation shall be made available to each child care 14 staff member or prospective child care staff member by the applicant or 15 licensee for at least one hundred eighty days after the last day of 16 employment or date the documentation was provided by the department, 17 whichever is later.

(d) (b) A child care staff member shall be required to undergo a 18 19 national criminal history record information check not less than once during each five-year period. A child care staff member shall submit a 20 complete set of his or her fingerprints to the Nebraska State Patrol. The 21 Nebraska State Patrol shall transmit a copy of the child care staff 22 23 member's fingerprints to the Federal Bureau of Investigation for a 24 national criminal history record information check. The national criminal 25 history record information check shall include information concerning child care staff members from federal repositories of such information 26 and repositories of such information in other states, if authorized by 27 federal law for use by the Nebraska State Patrol. The Nebraska State 28 Patrol shall issue a report to the department that includes the 29 information collected from 30 the national criminal history record information check concerning child care staff members. The department 31

shall seek federal funds, if available, to assist child care providers 1 2 and child care staff members with the costs of the fingerprinting and national criminal history record information check. If the department 3 does not receive sufficient federal funds to assist child care providers 4 and staff members with such costs, then the child care staff member being 5 screened, applicant for a license, or licensee shall pay the actual cost 6 7 of the fingerprinting and national criminal history record information check, except that the department may pay all or part of the cost if 8 9 funding becomes available. The department and the Nebraska State Patrol may adopt and promulgate rules and regulations concerning the costs 10 associated with the fingerprinting and the national criminal history 11 record information check. The department may adopt and promulgate rules 12 13 and regulations implementing national criminal history record information check requirements for child care providers and child care staff members. 14

(e) (c) A child care staff member shall also submit to the following
 background checks at his or her expense not less than once during each
 five-year period:

(i) A search of the National Crime Information Center's National Sex
Offender Registry; and

(ii) A search of the following registries, repositories, or databases in the state where the child care provider is located or where the child care staff member resides and each state where the child care provider was located or where the child care staff member resided during the preceding five years:

27 (C) State-based child abuse and neglect registries and databases.

28 (f) Background checks shall be portable between child care

30 (g) (d) Any individual shall be ineligible for employment by a child

12 (i) (f) A child care provider shall be ineligible for a license 13 under the Child Care Licensing Act and shall be ineligible to participate 14 in the child care subsidy program if the provider employs a child care 15 staff member who is ineligible for employment under subdivisions (e) or 16 (f) (d) or (e) of this subsection.

17 (j) (g) National criminal history record information and information 18 from background checks described in this subsection subject to state or 19 federal confidentiality requirements may only be used for purposes of 20 granting a child care license or approving a child care provider for 21 participation in the child care subsidy program.

Public purpose does not include leasing of property to a 23 private party unless the lease of the property is at fair market value 24 for a public purpose. Leases of property by a public housing authority to 25 low-income individuals as a place of residence are for the authority's public purpose; 26

(b) Unleased property of the state or its governmental subdivisions which is not being used or developed for use for a public purpose but upon which a payment in lieu of taxes is paid for public safety, rescue, and emergency services and road or street construction or maintenance services to all governmental units providing such services to the

property. Except as provided in Article VIII, section 11, of the 1 2 Constitution of Nebraska, the payment in lieu of taxes shall be based on the proportionate share of the cost of providing public safety, rescue, 3 or emergency services and road or street construction or maintenance 4 services unless a general policy is adopted by the governing body of the 5 governmental subdivision providing such services which provides for a 6 different method of determining the amount of the payment in lieu of 7 taxes. The governing body may adopt a general policy by ordinance or 8 9 resolution for determining the amount of payment in lieu of taxes by majority vote after a hearing on the ordinance or resolution. (3) Tangible personal property which is not depreciable tangible
 personal property as defined in section 77-119 shall be exempt from
 property tax.

(4) Motor vehicles, trailers, and semitrailers required to be
registered for operation on the highways of this state shall be exempt
from payment of property taxes.

(5) Business and agricultural inventory shall be exempt from the 17 personal property tax. For purposes of this subsection, 18 business inventory includes personal property owned for purposes of leasing or 19 renting such property to others for financial gain only if the personal 20 property is of a type which in the ordinary course of business is leased 21 or rented thirty days or less and may be returned at the option of the 22 23 lessee or renter at any time and the personal property is of a type which 24 would be considered household goods or personal effects if owned by an 25 individual. All other personal property owned for purposes of leasing or renting such property to others for financial gain shall not be 26 considered business inventory. 27

(6) Any personal property exempt pursuant to subsection (2) of
section 77-4105 or section 77-5209.02 shall be exempt from the personal
property tax.

31 (7) Livestock shall be exempt from the personal property tax.

(8) Any personal property exempt pursuant to the Nebraska Advantage
 Act or the ImagiNE Nebraska Act shall be exempt from the personal
 property tax.

(9) Any depreciable tangible personal property used directly in the 4 generation of electricity using wind as the fuel source shall be exempt 5 from the property tax levied on depreciable tangible personal property. 6 7 depreciable tangible personal property used directly in the Any generation of electricity using solar, biomass, or landfill gas as the 8 9 fuel source shall be exempt from the property tax levied on depreciable tangible personal property if such depreciable tangible personal property 10 was installed on or after January 1, 2016, and has a nameplate capacity 11 of one hundred kilowatts or more. Depreciable tangible personal property 12 used directly in the generation of electricity using wind, solar, 13 14 biomass, or landfill gas as the fuel source includes, but is not limited to, wind turbines, rotors and blades, towers, solar panels, trackers, 15 16 generating equipment, transmission components, substations, supporting structures or racks, inverters, and other system components such as 17 wiring, control systems, switchgears, and generator step-up transformers. 18 (10) Any tangible personal property that is acquired by a person 19 operating a data center located in this state, that is assembled, 20 engineered, processed, fabricated, manufactured into, attached to, or 21 22 incorporated into other tangible personal property, both in component 23 form or that of an assembled product, for the purpose of subsequent use 24 at a physical location outside this state by the person operating a data 25 center shall be exempt from the personal property tax. Such exemption extends to keeping, retaining, or exercising any right or power over 26 tangible personal property in this state for the purpose of subsequently 27 transporting it outside this state for use thereafter outside this state. 28 For purposes of this subsection, data center means computers, supporting 29 equipment, and other organized assembly of hardware or software that are 30 31 designed to centralize the storage, management, or dissemination of data

and information, environmentally controlled structures or facilities or
interrelated structures or facilities that provide the infrastructure for
housing the equipment, such as raised flooring, electricity supply,
communication and data lines, Internet access, cooling, security, and
fire suppression, and any building housing the foregoing.

6 (11) For tax years prior to tax year 2020, each person who owns 7 property required to be reported to the county assessor under section 8 77-1201 shall be allowed an exemption amount as provided in the Personal 9 Property Tax Relief Act. For tax years prior to tax year 2020, each person who owns property required to be valued by the state as provided 10 in section 77-601, 77-682, 77-801, or 77-1248 shall be allowed a 11 12 compensating exemption factor as provided in the Personal Property Tax 13 Relief Act.
