Explanation of Estimate:

The Youth Services Center could experience a fiscal impact as a result of transportation costs to/from evaluation sites, particularly if the site is outside of Lancaster County.

Additionally, the County would bear the cost of care for the first ten days after a youth has been ordered an evaluation, as well as after the completion of the evaluation pending court action. The exact dollar cannot be anticipated as this is dependent upon the number of youth entering the system.

Transportation costs may also be experienced by the Lancaster County Sheriff's office if applied to youth being evaluated within the community.
