LB 286 amends the Nebraska Liquor Control Act, Nebraska Revised Statutes Section 53-123.15 (4), regarding shipping licenses.

Currently, the fee for a shipping license in which the seller ships alcoholic liquor directly to a consumer in Nebraska is remitted for credit to the Winery and Grape Producers Promotional Fund. This provision is to sunset April 30, 2012 after which the fee will be credited to the General Fund.

The bill would remove the sunset date and the fee would continue to be credited to the Winery and Grape Producers Promotional Fund.

The Fund is used to develop and maintain programs for research and advancement, marketing, and promotion of grapes, fruits, berries, honey, and other agricultural products and their byproducts grown and produced in Nebraska for use in the wine industry. The Fund is under the administrative control of the Department of Agriculture.

The Liquor Control Commission indicates they have 264 S-1 (shipping) licensees that pay an annual license fee of \$500. The fiscal impact would be a reduction to the General Fund and an increase to the Cash Fund.

We agree with the Commission's estimate of fiscal impact.
