LB 588 amends the Conveyance Safety Act.

The bill changes the name of the Conveyance Advisory Committee to the Conveyance Committee and also changes the makeup and membership of the Committee. The bill requires that one member of the Committee be a representative of labor involved in the elevator industry and, after the expiration of the terms of the members from counties of more than 100,000 inhabitants, that the Governor fill those positions with representatives from three different counties to represent urban, suburban, and rural interests respectively.

Under current statute, the Committee serves as an advisory body to the Commissioner of Labor. LB 588 gives the Committee the authority and responsibility to adopt and promulgate rules and regulations for standard safety codes regarding conveyances. The Committee may also recommend legislative changes.

The bill changes authority to establish a schedule of fees for licenses, permits, certificates, and inspections authorized under the Conveyance Safety Act from the Commissioner of Labor to the Conveyance Committee.

The bill adds an inspection requirement for platform lifts and stairway chair lifts; these lifts are currently exempt from inspection.

LB 588 strikes the requirement for inspection of conveyances in private residences in counties with a population over 100,000 inhabitants at the time of installation and adds new language that exempts stairway chair lifts, platform lifts, and elevators installed in private residences from inspection requirements.

The bill also requires the licensing of elevator mechanics throughout the state. Current statute limits the licensing requirement to those elevator mechanics working in buildings or structures located in counties of more than 100,000 inhabitants.

The Department of Labor estimates the fiscal impact of LB 588 to be an increase of \$31,000 in FY2011-12 and \$29,437 in FY2012-13 to the Mechanical Safety Inspection Fund. This is based on an increase in licensure of approximately 25 elevator mechanics, an increase in the number of inspections of platform lifts and stairway chair lifts, and the elimination of the private residence inspection requirement.

The Department indicated no additional costs as a result of the changes to the Conveyance Advisory Committee.

There is no basis to disagree with the Department of Labor's estimate of fiscal impact.

Explanation of Estimate:

LB 588 adds an inspection requirement for platform lifts and stairway chair lifts, which are currently exempt under the Conveyance Safety Act. As a result of this change, there will be an estimated increase in revenue of \$29,100 (219 units).

LB 588 changes the Conveyance Safety Act to exempt conveyances in all private residences. The current Conveyance Safety Act requires an inspection on conveyances in private residences located in counties with a population of one hundred thousand or less inhabitants, only at the time of installation. This change will decrease revenues by \$600. This past year there were six conveyances installed in private residences in counties with a population of more than one hundred thousand inhabitants.

LB 588 requires licensing of elevator mechanics working in any county in Nebraska, not just in counties of one hundred thousand or more inhabitants as is the case with the current This will result in a slight increase in the number of licensed mechanics. An estimated twenty-five mechanics getting a license would result in an initial \$2,500 increase in revenue the first year and then an additional \$1,875 every other year. The initial license is \$100. The renewal license is \$75 issued every other year.

LB 588 changes the title, membership and duties of the current Conveyance Advisory Committee. It would become the Conveyance Committee and would become responsible for adopting and promulgating rules and regulations regarding the Conveyance Act and it would also, after a public hearing conducted by the commissioner or his or her designee, establish a reasonable schedule of fees for components of the program.

The changes to the committee will not result in a measurable increase to expenditures.
