LB 578 requires a person seeking to operate a pipeline to transport crude oil or any other hazardous liquid in the State of Nebraska to provide proof of financial responsibility with the Public Service Commission.

The PSC is responsible for determining the amount of the financial responsibility required by considering conditions specified by the Commission, the probable difficulty of completing the requirements of laws, rules, or regulations, conditions due to factors such as topography, geology of the site, hydrology, and the prior history of environmental activities of the operator.

The PSC estimates the impact of the bill's provisions to be \$500,000 per year. This is largely due to the areas of expertise required to fulfill the bill's requirements and the current lack of such expertise at the agency. The PSC would have to perform the required analysis on a contractual basis. Such levels of expertise will likely be costly. There is no basis to disagree with the estimate.



The Commission is to determine the amount of the financial responsibility required by considering conditions specified by the Commission, the probable difficulty of completing the requirements of laws, rules, or regulations, conditions due to factors such as topography, geology of the site, and hydrology, and the prior history of environmental activities of the operator. To perform the anlaysis, the Commission would enter into contracts with consultants and our estimate is \$500,000 to provide the necessary expertise to comply with the provisions of the bill.
