LB 754 amends the Nebraska Political Accountability and Disclosure Act.

Section 3 defines the terms: "Electioneering communication", "Clearly identified candidate", and "Voter guide".

The bill's provisions also require reporting to the Nebraska Accountability and Disclosure Commission (NADC) regarding electioneering communication.

The NADC estimates the cost to revise and reprint forms and fliers to be \$700. This estimate appears to be reasonable.
