LB 1157 changes provisions related to late filing fees imposed under certain sections of the Nebraska Accountability and Disclosure Act. The bill's provisions would make more filers eligible for relief from late filing fees.

The Accountability and Disclosure Commission estimates the need to reprint notification fliers at a cost of \$300. This estimate appears to be reasonable.

It is likely that the bill's provisions will result in a reduction of revenue due to decreased fee imposition. This amount cannot be estimated.
