**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

This bill authorizes the balance of a sum deposited of a bail bond that is not retained by the court or magistrate to be subject to a lien in the amount of any delinquent child support.

The Department of Health and Human Services may have increased collections for delinquent child support, but the amount is unknown. Some of the collections would reduce both state and federal costs as some child support collections go towards repayment of state and federal maintenance costs for families who have received Aid to Dependent Children assistance.

This would increase the workload for county attorneys and clerks. The impact would vary by county.
