LB616 authorizes license application fees of \$1,000 and annual license renewal application fees of \$250 to be paid to the Department of Banking and Finance under provisions of the Nebraska Money Transmitter Act which is to be adopted by the bill. These fees effectively replace license application and license renewal fees of equivalent amounts under provisions of the Nebraska Sale of Checks and Funds Transmission Act that would be repealed by the bill. The bill represents no net fiscal impact.
