#### **Explanation of Estimate:**

LB 373 amends the Nebraska Construction Prompt Pay Act by requiring a contractor to place funds intended for the payment of subcontractors in a separate trust account, limiting a party to withhold payment in an amount no greater than five percent of the contracted improvement cost, and providing contractors and owners the ability to bring an action to recover any damages by violation of the Act.

Section 2, subparagraph 2, of LB 373 defines the owner as excluding the State of Nebraska. Since this removes state owned projects, the bill has no fiscal impact for Administrative Services.
