LB 7 amends the Engineers and Architects Regulation Act, dealing with the seal required of every licensee authorized to practice architecture or engineering in Nebraska.

The bill removes the requirement of a written signature, specifies information that must be included on the seal, gives the Board of Engineers and Architects rule and regulation authority regarding application of the seal, and removes the requirement of an electronic revision approval system for electronic signatures applied to an electronic seal.

There is no fiscal impact to the state.
