Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 866 would amend Nebraska Revised Statutes Sections 53-105 and 53-106 regarding the membership of the Liquor Control Commission.

Section 53-105 is amended to increase the number of members of the Liquor Control Commission to five. Current membership is three. The section is further amended to provide that no more than three appointees would be members of the same political party, no more than three appointees would be citizens of the same congressional district, and there shall be one appointee from each congressional district.

Section 53-106 is amended to specify that the terms of members shall be for six years and shall begin in May of odd-numbered years, with the exception that one of the members appointed after the effective date of LB 866 shall hold office until May 2015 and one member until May 2017.

The Liquor Control Commission indicates that LB 866 will require \$72,827 per fiscal year to implement. Section 53-112 provides for an annual salary of \$12,500 for each commissioner. Because commissioners are considered state employees they are also entitled to benefits and expenses.

We agree with the Liquor Control Commission's estimate of fiscal impact.
