Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 222 creates the Fallen Heroes Memorial Commission and the Fallen Heroes Memorial Construction Fund. The purpose of the Commission is to accept applications from counties, townships, cities, and villages for grants to aid in the erection of statutes, monuments, and memorials honoring veterans who have lost their lives in armed conflict. These grants will be funded from the Fallen Heroes Memorial Construction Fund for up to one-third of the cost of design and construction.

The Commission will have five members and they are to be reimbursed for their actual and necessary expenses. These expenses will fluctuate based on the number of meetings and the location of the members, but a rough estimate could be made based on certain assumptions. If one night's lodging is \$85, meals are \$75, and mileage is \$100, the cost per meeting will be \$260 for each member, or \$1,300 in total for all five members. Based on three meetings per year the total cost would be \$3,900 General Funds for expense reimbursement each year.

The amount of money in the Construction Fund available for grants will depend on the size of the appropriation from the Legislature plus any gifts, grants, or donations. The bill is silent as to the intended size of the appropriation. The fund source would be the General Fund.
