This bill would change and eliminate child custody provisions and adopt the Uniform Deployed Parents Custody and Visitation Act. The bill would also outright repeal section 43-2929.01. Children of military parents; proceeding involving military parent; court; considerations; limitation on certain orders; attorney's fees.

The Supreme Court estimates a limited impact from this bill. They note that changes will have to be made to their computer system and court forms.

The Department of Health and Human Services estimates no fiscal impact from this bill.
