Explanation of Estimate:

LB 80 updates the dental anesthesia statutes to be more in line with the American Dental Association's Guidelines for the Use of Sedation and General Anesthesia by Dentists. The current structure focuses more on the route of administration, and these changes focus more on the level of sedation of the patient. The bill creates permits for administration of general anesthesia or deep sedation, moderate sedation, and minimal sedation, and eliminates the requirement of a permit for administration of inhalation analgesia (nitrous oxide). Language is included to transition currently existing permits to the new permits created by the bill. The bill includes an operative date of July 1, 2016, to allow the Board of Dentistry time to adopt regulations for implementation of the new law.

There is no fiscal impact to the Department of Health and Human Services.
