Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 269 amends Nebraska Revised Statutes, Section 76-550 of the Abstracters Act.

The bill would remove from statute the requirement that the Abstracters Board prepare a roster of abstracters holding an operative certificate of registration, showing their name and place of business, in June of each even-numbered year and send that roster to all registered abstracters.

The Abstracters Board of Examiners estimates a reduction in printing and publications expense of \$2,000 in FY15-16.

We disagree somewhat with the Board's estimate of fiscal impact. Based on expenditure records for the previous five years, the reduction will take place in FY16-17.
