LB 207 would have no fiscal impact on state agencies.

LB 207 provides that when the Attorney General, county attorney or private attorney brings a civil action on behalf of a natural resources district regarding a violation of the Nebraska Chemigation Act, that the district shall recover the costs of the action if a civil penalty is awarded. LB 207 would also establish minimum and maximum monetary penalties under the act. The fiscal impact to natural resources districts would be limited to instances when a civil action was undertaken and a penalty was awarded.
