Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 439 amends the Nebraska Liquor Control Act.

Section 53-180.05 is amended to provide an exception for the penalty imposed by Section 53-180.02. This section prohibits a minor from selling, dispensing, consuming, possessing or having physical control of any alcoholic liquor outside of their permanent place of residence. The penalty is a Class III misdemeanor.

New language states there shall be no penalty imposed if a person in violation is requesting emergency medical assistance in response to a possible alcohol overdose of themselves or another person as soon as the emergency is apparent after such violation.

In addition, they have to be the first person making the request for medical assistance; and, if they are making the request for another person they have to remain on the scene until medical assistance arrives and must cooperate with medical assistance and law enforcement.

Section 53-181, which deals with the penalties for violation of Section 53-180.02, which include Class III misdemeanor and can include loss of their motor vehicle operator's license, the same immunity as described above is applied.

The Liquor Control Commission indicates no fiscal impact as a result of LB 439.

We agree with the Commission's estimate of fiscal impact.
