Explanation of Estimate:

Section 2 requires the DHHS to develop and maintain a dedicated Internet web page with abortion related information as described and as found in 28-327.01; notify abortion providers on the location of the information; make web page user-friendly and searchable; allow for printing, make accessible without registration or password; and include a video of ultrasound images, using the best available ultrasound technology of an unborn child at two-week gestational increments.

Section 3 requires abortion providers to include a link to this page to the DHHS web page meeting specified technical and content requirements.

Sections 4 and 5 require any health care facility and any health care practitioner facility that provides abortion services to post signage in a conspicuous place with legible lettering that is at least three-quarters of an inch and in boldface type that informs persons that it is against the law for anyone to force one to have an abortion; that by law, no one can perform an abortion against a female's will; that a person has the right to contact any local or state law enforcement agency to receive protection from any actual or threatened physical abuse or violence. Any health care facility that fails to post the required sign will be assessed a \$500 fine. Each business day during which such sign is not posted and abortions are performed, except when necessary to prevent the death of the woman, will constitute a separate violation.

The Department of Health and Human Services can handle the Fiscal Impact with existing resources.
