**Explanation of Estimate:**

LB556 provides that an employer, when being found guilty of willful negligence, loses the right to interpose the three defenses mentioned in Neb. Rev. Stat. § 48-102. Additionally, LB556 would allow the employee to bring an action at law for damages after the Workers' Compensation Court has determined that the employer was willfully negligent.

It would be difficult to predict actual costs and damages subject to the intent of LB556 for purposes of determining potential fiscal impact, however, this bill could increase exposure to the State.
