**Explanation of Estimate:**

The proposed legislation makes some changes to the Niobrara Council membership. The county board members shall be commissioners from the respective boards. The National Park Service and US Fish and Wildlife Service members shall be the respective regional directors of those agencies or their designee. They could only vote on matters if formally authorized by their respective agencies and had notified the council and Governor in writing.

Language prohibiting a member from participating or voting on a matter on which he/she had participated or voted on as a member of a county board, commission or district board member has been struck.

No fiscal impact is anticipated.
