LB 404 would require the Department of Natural Resources to publish a notice of a water appropriation or permit application, and to grant public water managers or users a hearing to present evidence regarding a water appropriation permit application. The agency would be required to hold a single evidentiary hearing unless the hearing is waived by the applicant.

The Department of Natural Resources states that it would initially use existing staff and budget resources to carry out the provisions of LB 404. It should be noted that if in future years, a significant backlog develops in administering applications or hearings, the consideration of additional funding or staffing may become necessary.
