Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill requires the Department of Health and Human Services to contract for a study of rates paid under Medicaid for Alzheimer's special care units, including a comparison to nursing facility rates for patients with Alzheimer's, the advantages and disadvantages of an add-on Medicaid waiver rate structure or a tiered rate structure, the eligibility criteria for reimbursement and an evaluation process to identify client outcomes and service quality. The study is to be completed by July 1, 2015. The bill states the cost cannot exceed \$50,000. The bill has the emergency clause.

Due to the timeframe in which the study must be completed, the maximum \$50,000 cost would be in FY 15. Fifty percent of the costs would be federal and fifty percent from the General Fund.

Technical Note: Rule 8, Section 5, requires A-Bills with a General Fund impact to be held until after the appropriations bills are passed by the legislature. This bill has a General Fund impact. Since the appropriations bills likely won't be passed until the middle of May, there is very little time to secure a contract and have the required work completed by July 1, 2015.

Medicaid Administrative matching funds will be available at 50%, therefore, the fiscal impact to the Department of Health and Human Services will be \$50,000 (\$25,000 GF / \$25,000 FF)
