Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 341 provides for private insurance plans to reimburse political subdivisions for any service or supply covered by a plan when an insured is in the custody of a jail pending disposition of charges. The care for the insured may be provided by an employee or contractor of a political subdivision if the employee or contractor meets the credentialing criteria of the health benefit plan. The bill is effective for the reimbursement of medical expenses on or after January 1, 2015.

Impact on Political Subdivisions: The bill may have a fiscal impact for political subdivisions (cities, counties) which provide medical care or medical supplies for persons who have health coverage who are in custody, pending the disposition of charges. There will be an unknown increase in revenue for political subdivisions which opt to be reimbursed for medical care or supplies. Political subdivisions will have an increased workload and may incur additional expenses to determine if individuals are covered by insurance and to bill insurance providers for covered services and supplies.
