The bill adds language to the section that the federal Uniformed Services Employment and Reemployment Right Act of 1994, U.S.C. Chapter 43 as adopted by Nebraska law also applies to a person who is employed in Nebraska but is a National Guard member of another state and who is called into active service by the Governor of that state.

There is no fiscal impact to the state as a result of LB 753.
