LB 1033 requires the Department of Health and Human Services (HHS) to develop a comprehensive strategic plan for placing qualified persons with disabilities in the most integrated community-based settings. HHS is to convene a team of persons from the six divisions of the agency to assess components of the strategic plan; consult with other state agencies that serve persons with disabilities; and, appoint an advisory committee to assist in reviewing and developing the plan. The advisory committee is required to have at least fifteen members as specified by the bill.

HHS is to determine whether a consultant is needed to assist in developing the plan and provide a progress report to the Legislature and Governor by December 15, 2016. A subsequent progress report is required by December 15, 2017 and a completed strategic plan is to be provided by December 15, 2018.

HHS indicates the department is currently in the process of a long-term services and supports redesign project which includes the required components of the bill. The department will utilize existing staff and resources in FY2016-17 to continue the redesign project and the development of a strategic plan. The bill provides for the department to indicate whether a consultant will be needed in CY2017 to complete the strategic plan, so there may be general funds required for such purpose in the future.
