Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would provide for expungement of records for persons charged with or found guilty of a crime because of stolen identity or mistaken identity.

The Supreme Court states that this bill will increase judicial and court workload from additional hearings, orders of expungement, and notice requirements. The Court notes that the extent to which a workload increase will have a fiscal impact is unknown at this time. In addition, education and new processes would be required for judges and court staff, but these items can be accomplished within existing funding and staff.

The Department of Motor Vehicles, Nebraska State Patrol, and the Crime Commission all estimate no fiscal impact from this bill.
