LB 112 changes provisions related to voter registration and provisional ballots.

The bill's provisions allow for provisional voting for any registered voter in the state and requires the Secretary of State to promulgate rules and regulations establishing procedures for election commissioners and county clerks.

The Secretary of State estimates the need to hire a consultant to assist with researching and drafting needed rules and regulations. The cost for this consultant is estimated to be \$54,000 plus \$4,000 in travel expenses. There is no basis to disagree with this estimate.
