LB353 changes provisions relating to the payment of claims, awards, and judgements under the Political Subdivisions Tort Claims Act.

LB353 adds to the list of instances under which claims, awards or judgements shall be paid against a political subdivision to include any judgement obtained in any court of competent jurisdiction in this state (77-1619). This could include payments of judgements entered by a federal court in Nebraska.

It would appear that this change has the potential to increase costs dependent on subsequent actions of parties subject to claims, awards, and judgements and the State Treasurer.
