Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 301 the Employment Security Law, Nebraska Revised Statutes Section 48-632.

The bill adds new language regarding notification upon determination of a claim that it may be either electronic or mailed and that the claimant shall elect one or the other upon filing a new claim or establishing a new benefit year. They may change the election at any time.

The Department of Labor indicates that postage costs are approximately \$292,921 for the fiscal year and they estimate that one-third of claimants will elect to receive notice electronically for a savings of \$98,307.

We have no basis to disagree with the Department of Labor's basic estimate of fiscal impact. However, because the bill does not contain the emergency clause, if passed it will not become operative until early to mid-September, which is one-quarter of the way into the fiscal year. Therefore, we are reducing the Department's estimated fiscal impact for FY2017-18 to reflect the shortened time the bill will be in effect for FY2017-18.
