Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would change provisions relating to the issuance of subpoenas.

The Supreme Court estimates a \$90,000 one-time Cash Fund expenditure increase for training (\$15,000) and JUSTICE changes (\$75,000). The Supreme Court notes that since there is no increase in Cash Fund revenue in the bill, Cash Fund balances may decrease. See the Court's response for additional details.

The City of Imperial and the City of Lincoln both estimate no fiscal impact.

The City of Omaha states that the bill could have a significant fiscal impact to them because witness fees and mileage costs for the defendant's witnesses revert to the city when the defendant is acquitted or unable to pay. Omaha notes that the cost is difficult to estimate at this time.
