Explanation of Estimate:

LB 585 proposes a number of changes to the dangerous dogs and cruelty to animals statutes, including making it a criminal offense to knowingly, recklessly or negligently own, keep or harbor a dangerous dog without having the dog spayed or neutered and posting warning signs required by 54-618 and 54-619. Violation of these provisions is punishable as a class IIIa misdemeanor.

NDCS estimates no fiscal impact from the changes proposed in LB 585 as the offense created in LB 585 is a class IIIa misdemeanor with a maximum penalty of a 7 day jail term.
