Section 2 removes the exception that a candidate committee may make a contribution to another candidate committee for a fundraising event of such other candidate committee under section 49-1479.

The Nebraska Accountability and Disclosure Commission estimates a cost of \$250 to reprint instructional materials. This estimate appears to be reasonable. Due to the low amount, it is assumed that the Commission will be able to absorb this cost.
