The Department of Correctional Services (NDCS) states that they are currently investigating the costs of acquiring an electronic health records system (EHR). Last Session, NDCS received funds for a one-time consultant fee of \$150,000 to develop a planning engagement document for an EHR software system. NDCS states that they are using these funds to investigate the feasibility and options for acquiring an EHR.
