LB 547 changes provisions related to the Nebraska Educational Savings Plan Trust.

Section 9 creates the College Savings Plan Endowment Fund. Until July 1, 2020, the State Treasurer shall accept qualified private contributions and shall credit all such contributions received to the College Savings Plan Endowment Fund. On July 1, 2020, the State Treasurer shall determine the total amount of qualified private contributions received and transfer an equal amount from the General Fund to the College Savings Plan Endowment Fund. All investment earnings from the College Savings Plan Endowment Fund shall be credited to the College Savings Plan Cash Fund.

Section 10 creates the College Savings Plan Cash Fund, which shall be used to provide state matching grants under the College Savings Plan Matching Grant Program.

Section 11 creates the College Savings Plan Matching Grant Program.

The State Treasurer anticipates no fiscal impact from the provisions of LB 547.

There will be a General Fund cost on July 1, 2020 for the bill's required match of contributions. The amount of that impact cannot be determined.
