Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 270 changes provisions relating to motor vehicles. There are several changes in the bill that will impact the workload of the Department of Motor Vehicles (DMV). The bill provides that drivers' licenses and state identification cards must be renewed in person at least once every sixteen years, rather than the current requirement for persons to appear once every ten years. LB 270 also allows an individual, whose license expires prior to their 72<sup>nd</sup> birthday, to renew a Class M drivers' license electronically twice, rather than once, as allowed by current law.

These changes will increase the workload of the DMV to renew licenses electronically and decrease the workload of DMV examiners to renew licenses in person. It is assumed the change in renewal requirements will not result in an increase or decrease in the number of staff employed by the department, so no fiscal impact is projected.
