LB 190 removes:

- A requirement that the Aeronautics Commission promulgate rules and regulations related to the allocation of state funds for the promotion of aviation.
- A requirement that the Department of Transportation promulgate rules and regulations related to the disclosure of information regarding alcohol and drug levels found in the body fluid of an individual who dies or is injured as a result of a motor vehicle accident.
- A requirement that the Department of Transportation promulgate rules and regulations related to uniform standards for school bus loading area warning signs and refers school districts to a “manual” that will contain the requirements related to school bus loading areas.

The changes proposed in LB 190 have no fiscal impact.
